- >>> 1- Being single and not having children.
- >>> 2- Do not have a criminal record.
- >>> 3- Be between 17 years old and a maximum of 25 years old. (At the time of delivering documents, The applicant must be at least 18 years of age for Latin Americans and 21 for citizens of Miami. The applicant can only remain in the program until they are 27 years old).
- >>> 4- Have or be willing to acquire an intermediate level of conversational English (minimum level B1), which allows you to have a conversation. Applicants to the Global Childcare UK program will be evaluated by a Global Exchange International Process Advisor, who according to their performance approves her progress in the process or determines if they need more time to preparation in the language to reschedule a new interview, taking into account that the age requirement allows it. Even when the interview is approved, the applicant has the commitment to maintain or improve the level of English throughout their application process; they must take the SELT (Secure English Language Test) exam and demonstrate the minimum level requested by the program, this exam is required by the immigration authorities of the United Kingdom
- >>> 5- Have excellent health, not have had a history of physical, psychological, psychiatric and / or eating disorders. Not be under medical treatment that requires medication or constant medical check-ups.

 IMPORTANT: In case of presenting any particular clinical situation, you should first consult with your process advisor.







Do que você precisa para viver a sua melhor experiência

- >>> 6- Have aptitude, pleasure and experience in caring for children. In case you don't have much experience be willing to acquire it and provide the certifications as a requirement of the application. Provide at least 2 NON-family childcare experiences in the last 5 years. The number of hours will depend on the applicant's profile to apply to the program.
- >>> 7- Be willing to comply with the minimum stay of 1 year with the Program
- >>> 8- During the stay as "Childcare UK"; You can NOT smoke and / or drink intoxicating drinks, as the work is focused directly on childcare and this is one of the requirements demanded by families.
- >>> 9- The applicant must be trained or willing to acquire the requirement of First Aid and Swimming in your home country. You must providet the certificates
- >>> 10- During the coexistence with the host family, you must assume the role of older sibling and responsible adult.
- >>> 11- The "Childcare UK participant" must cover the cost of medical insurance in the United Kingdom for the year (approximately £ 624), this amount will be refunded within 6 or 12 months of your stay.
- >>> 12- For the visa process the "Childcare UK participant" must assume the registration biometric fee.
- >>> 13- Do not have a rejected visa to any country in the United Kingdom. Not having residency applications or political asylum in other countries, or that these have been approved. Not having breached the conditions of visas acquired to other countries.







There are two types of profile for this program:

Profile "Global Childcare UK Standard"

- Work within their functions "Childcare UK" approximately 25.5 hours per week
- Must have a minimum of 200 hours of childcare.

Benefits of "Global Childcare UK Standard"

- Weekly salary of approximately £ 138.09
- For each overtime, you will have a remuneration of £ 6.07 per hour, maximum work of 45.5 hours a week







Profile "Global Childcare UK Pro"

- Work within their functions "Childcare UK" up to 35 hours per week
- Must have a minimum of 300 hours of childcare
- Childcare experience must be acquired in daycare centers or schools with referrals verifiable.
- Must have a diploma or courses related to education, children development or be a health professional
- Previous experience as an Au Pair in any destination with verifiable references
- Only experience with unfamiliar babies.

Benefits "Global Childcare UK Pro"

- For the 35 hours of work; weekly wage of £ 189.70
- For each overtime, you will have a remuneration of £ 6.07 per hour, maximum work of 45.5 hours per week.



A "Host Family", família anfitriã, espera que seu "Global Childcare UK"

- >>> Be a supportive and responsible adult in the absence of parents.
- >>> Be a mature, honest, responsible, proactive, patient person, who takes on challenges and has good common sense.
- >>> Ensure the protection, safety and care of children.
- >>> Watch over the feeding of children when they are in your care.
- >>> Help children with academic and extracurricular homework.
- >>> Play and take care of the children in the family.
- >>> Ensure an orderly environment for children.
- >>> As a member of the family, you must help keep the place where you live organized.
- >>> Positively share your language and culture.
- >>> Be an active member of the host family, participate in their activities, cultural, social and share their customs.
- >>> Be prudent and respectful of the host family's rules, customs, and beliefs.

 The functions are previously agreed with the Family, it is likely that this requires that their "Childcare UK" perform some of the functions that are not mentioned, but that are allowed by the program

- >>> The opportunity to live the experience in a "Host Family" in one of the countries of the United Kingdom. The countries are: Northern Ireland, Wales, Scotland or England
- >>> The possibility of improving your level of English through cultural Exchange
- >>> Have a legal work experience in the United Kingdom and with this improve your Curriculum Vitae.
- Opportunities to study and obtain a recognized degree in the UK (not required), payment is at the applicant's expense
- >>> Possibility of extending the visa for up to 5 years (this will depend on age, it is allowed to be up to 27 years as "Global Childcare UK")
